#### MEMBERSHIP REQUIREMENTS

- The membership in the Association shall consist of:
  - a) be a person at least nineteen years of age, of sound mind, and of Italian Origin. A person of Italian origin shall be defined as being a person having at least one parent of Italian descent, and
    - be a self-employed business person; or
    - be a professional person that holds a degree or certificate or diploma from a recognized postii) secondary educational institution; or
    - iii) be an executive, officer, director of a corporation; or
    - iv) be a member of the clergy; or
    - v) be engaged in any other business, vocation or occupation (including retirement), which the Board by majority vote deems satisfactory for membership; and
    - vi) file an application in writing sponsored by one member in good standing, the application to be in a form approved by the Board from time to time; and
    - vii) be approved by a majority vote at a meeting of the Board provided a quorum is present, and
    - viii) pay all fees, dues, or other assessments as determined by the Board;

#### GENERAL POLICIES

- a) All applications must be approved by the board of Directors;
- b) All applications must be accompanied by a cheque for the membership dues for one year;
- Monthly meetings are held on the first Tuesday of the month from September to June unless otherwise notified by the Board of Directors;
- If a member chooses to invite a guest, then CIBPA will simply bill the member for that guest's dinner;
- e) Guests may not have the floor during the business meeting;
- f) Any member may attend an executive meeting by informing the President of his intention in advance.

#### **MEMBERSHIP DUES**

- All fees, dues, or other assessments levied at a rate as may be determined by the Board from time to time.
- b) Current dues is \$20 / member, included with application
