We will also make them available at the December 7, 2010 meeting.

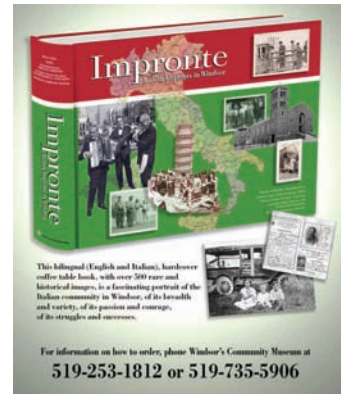
