## **STRUCTURE**

- A non-profit corporation;
- A nine member Board of Directors elected by mail-in ballot once per year;
- Presidents term of office is two years and may stand for election to a second term;
- No Board Member may hold a position on the Board of Directors for more than three successive years;
- All projects managed by Committee Chairperson chosen by Board of Directors.

#### **GENERAL POLICIES**

- All applications must be approved by the board of Directors;
- All applications must be accompanied by a cheque for the membership dues for one year;
- Membership fees are deductible for Income Tax purposes, except for fees paid by individuals on salary;
- Monthly meetings are held on the first Tuesday of the month from September to June unless otherwise notified by the Board o Directors;
- If a member chooses to invite a guest who does not meet the criteria for membership, then CIBPA will simply bill the member for that guest's dinner;
- Guests may not have the floor during the business meeting;
- Any member may attend an executive meeting by informing the President of his intention in advance.

#### **MEMBERSHIP REQUIREMENTS**

#### **OFFICIAL MEMBER**

- be a Natural Person, at least 19 years of age and of Italian Origin; and
- be self employed carrying on a business; or
- be a professional person that holds a degree or certificate or diploma from a recognized post secondary educational institution; or
- be an executive, officer, director of a corporation; or
- be a member of the clergy; or
- be engaged in any other business, vocation or occupation, (including
- retirement), which the Board by majority vote deems satisfactory for
- membership; and
- file an application in a form approved by the Board from time to time
- sponsored by one Official Member in good standing; and
- be approved by a majority of the Board;

## **JUNIOR MEMBER**

- be a Natural Person between the age of 19 and 30 years and of Italian origin; and
- be in full-time attendance at a recognized post secondary educational institution; and
- file application in a form approved by the Board from time to time
- sponsored by one Official Member in good standing and
- be approved by a majority of the Board;

## **ASSOCIATE MEMBER**

- be a Natural Person at least 19 years of age who does not qualify to be a Voting Member; and
- be self employed carrying on a business; or
- be a professional person that holds a degrees or certificate or diploma from a recognized post secondary educational institution; or
- be an executive, officer, or director of a corporation; or
- be a member of the clergy; or
- be engaged in any other business, vocation or occupation, including retirement, approved by the Board; and
- file an application in a form approved by the Board from time to time
- sponsored by one Official Member in good standing; and
- be approved by a majority of the Board; and
- Associate membership shall be limited to 10% of the Official Members enrolled with the Corporation as of the preceding fiscal year end; and
- if the number of Official Members decreases the following fiscal year, the current Associate Members can remain even if the 10% limit is exceeded

#### **CORPORATE MEMBER**

- be a person that is not a Natural Person; and
- appoint an authorized representative who is at least 19 years of age and of Italian Origin; and
- file an application in a form approved by the Board from time to time
- sponsored by one Official Member in good standing; and
- be approved by a majority of the Board;
